Updates on actions from January 2025 meeting

Item 13 - Point Orchard Septic Tank issue

Update received from homeowner regarding progress with getting information from solicitor about right to use septic tank on Parish Council land, currently awaiting this information. Environmental Health spoken to and email response to questions raised circulated to all Councillors.

Item 14 - CCF COMMUNITY LEVELLING UP FUNDING

Council to consider if they wish to apply for further funding, the project detail/outline needs to be agreed at the Parish Council meeting if they do wish to apply, due to short timescales. We have received CCF funding previously for the Active Feock Feasibility Study and also the benches we have recently installed were funded by CCF.

There is now further funding available and it has been suggested that something that could be applied for is bike racks across the parish and also the production of the Feock Strolls walk leaflet which are both identified as outcomes in the Feasibility Study.

The summary of the funding criteria is below (copied from Cornwall Council's website)

Community Capacity Funding

This fund supports community organisations to develop projects or project ideas with grants of between £1,000 and £24,999. Organisations will then be in a stronger position to access wider funding opportunities.

Examples of work that could be funded by the Community Capacity programme include:

- feasibility studies
- business plans
- architects' drawings
- concept plans
- other professional support to determine the concept of your project
- community engagement programmes leading to the development of a wider project, including piloting community project ideas
- small capital items that will result in the increase in community activity.

Open for applications between February and November 2025 and applications will close when all money is spent so time is of the essence. Funds need to be spent by end of December 2025.

Item 16 - Grant to St Feock Church for Churchyard Maintenance

Currently the Parish Council give a grant of £420 each to St Feock Church and Devoran Church to help with maintenance of the Churchyard. A request has been received below to increase this from St Feock Church (copied from their letter).

This is the application for the 2024 annual Churchyard Grant which the Council has maintained at the same level for many years. As you are aware property maintenance costs continue to escalate, and the churchyard is no exception. The churchyard is maintained to a high standard. In 2024 churchyard expenditure amounted to £4982. As the local precept continues to rise perhaps the Council would consider an increase to the annual grant? Maintaining the church grounds is an important amenity for the Feock villagers and the Church ground provides quiet space to reflect on loved ones.
